WELCOME AND INTRODUCTIONS

EPSO Workgroup Co-Leads Robin Hebert and Harmony Little welcomed the members of the workgroup and provided brief introductions. Members were asked to provide their name, organization, and role in the workgroup. The meeting agenda and meeting objectives were reviewed and discussed.

OVERVIEW OF THE COMMONWEALTH EDUCATION CONTINUUM (CEC)

Robin Hebert provided an overview of the goals, membership, and annual objective of the CEC and provided an explanation of how the CEC developed the comprehensive list of their prioritized recommendations through stakeholder engagement and input from the workgroup members.

REVIEW CURRENT DATA

Lauren Norton, Education Strategy Group Senior Associate, Jessica Cunningham, and Logan Rupard from KYSTATS provided a presentation on data related to Early Postsecondary Opportunities in Kentucky. Workgroup members discussed the data that was presented and engaged in a deeper conversation of what the data means and how it ties to the work of the group.

WORKGROUP PROPOSED ROLES AND EXPECTATIONS

Robin Hebert provided an overview of the workgroup purpose to expand access and attainment of early postsecondary opportunities for all of Kentucky's students with an emphasis on the Commonwealth's underrepresented students. Workgroup members were asked to provide topics they think are most pressing for the state to address and how the work of the group can successfully address concerns. Workgroup members reviewed and discussed their roles and responsibilities to attend meetings and to share their expertise with the group. Their role as advocates for the workgroup and the CEC and the broader desire to build awareness and buy-in among key stakeholders and promote the work of the Continuum was also reviewed.

STAKEHOLDER ENGAGEMENT EFFORTS

Harmony Little provided an overview of the plan for capturing stakeholder feedback through focus groups and interviews to ensure a diverse group of voices are represented. Each workgroup member was asked to conduct at least one stakeholder interview or focus group by June 30, 2022.

NEXT STEPS AND ADJOURNMENT

Harmony Little thanked the workgroup members for their willingness to serve the Commonwealth as a member of the EPSO workgroup and provided information on where materials for the workgroup are located.
