2. submitting an estimated timeline of the process steps and quarterly reports to the Council on Postsecondary Education (CPE) until it obtains accreditation with an accrediting agency recognized by the U.S. Department of Education;

3. providing CPE with documentation of membership with KYVL before enrolling students;
4. providing any other updates upon CPE request until such time as the university is accredited with an accrediting agency recognized by the U.S. Department of Education;
5. submitting to a site visit conducted by CPE to determine the college's compliance with its licensing standards. CPE will contact the institution to schedule this site visit sometime after classes have begun, and CPE will provide an invoice for the estimated site visit costs that must be paid prior to the site visit.

This conditional license is effective through **June 30, 2018**. Once CPE receives assurance that the university has satisfied these conditions, CPE will remove the university from conditional license status. A conditional license may not exceed two (2) years. Failure to satisfy the conditions in that time frame may result in revocation of the university's license or an extension of the conditional license upon request of the institution with supporting justification.
